#### Outline of International Priority Graduate Programs/PGP

#### **◆**Master of Asia Design Education/MADE Program

This program is to address the expanding field of industrial design, and offers educational research in Asia centering on service design and engineering design. The program is jointly run by Chiba University and six major Asian universities: Seoul National University (Korea), Yonsei University (Korea), Tsinghua University (China), Zhejiang University (China), Nanyang Technological University (Singapore) and Institut Teknologi Bandung (Indonesia). Students of particular excellence will be invited to Chiba University to study for a master's degree. The program consists of the Double Degree Program, where students will obtain a degree each from the two universities, and the Degree Program where students will only obtain a degree from Chiba University.

#### **♦**Global Service and Product Design/GSPD Program

The objective of this program is to develop human resources with advanced design skills by learning designs that extensively blend various services and products needed for our lives. Students who enroll in this practical program will major in Design Science at the Graduate School of Engineering and learn about the field of Service & Product Design, in which Japan is a world leader. This program also aims to develop human resources to perform applied research in the future.

#### 2. Required Qualifications

#### 2-1 Master of Asia Design Education/ MADE Program

1) Current students of sister universities, including Seoul National University (Korea), Yonsei University (Korea), Tsinghua University (China), Zhejiang University (China), Nanyang Technological University (Singapore) and Institut Teknologi Bandung (Indonesia), or students who have graduated

- from (completed studying at) a sister university in approximately the last two years.
- 2) Those who have been successfully selected for the International Priority Graduate Programs/PGP for which Japanese Government (MEXT) scholarship international students, or personally-funded international students who are nominated by a sister university, are given preference.

Only those who fulfill the two conditions set forth above as well as one of the following can apply for this program.

- (1) They must have completed a 16-year course of study in the educational institutions in a foreign country, or expect to complete such a course of study by September 2013.
- (2) They must have completed a 16-year course of study in the educational institutions of a foreign country, or expect to complete such a course of study by September 2013, after taking a correspondence course offered in Japan by a foreign school.
- (3) They must have completed a 15-year course of study in the educational institutions in a foreign country, or must have completed a 15-year course of study in the educational institutions of a foreign country after taking a correspondence course offered in Japan by a foreign school, by September 2013 and have been recognized by the Graduate School of Engineering as having obtained the prescribed number of credits with superior grades.
- (4) They must have been recognized to have scholastic attainments that are at least the equivalent of those of graduates of foreign universities, based on an examination, conducted by the Graduate School of Engineering, of the applicant's qualifications to enter this school, and be also 22 years of age or be going to turn 22 by September 2013.

Applicants who would meet the Required Qualifications (3) or (4) above need another procedure in advance. Please see "11 Request for Judging Applicant's Qualification to Take the Entrance Examination".

#### 2-2 Global Service and Product Design/GSPD Program

- 1) Those who have been successfully selected for the International Priority Graduate Programs/PGP for which Japanese Government (MEXT) scholarship international students are given preference.
- 2) Those who do not reside in Japan at the time of application.

Only those who fulfill the two conditions set forth above as well as one of the following can apply for this program.

- (1) They must have completed a 16-year course of study in the educational institutions in a foreign country, or expect to complete such a course of study by September 2013.
  - (2) They must have completed a 16-year course of study in the educational institutions of a foreign country, or expect to complete such a course of study by September 2013, after taking a correspondence course offered in Japan by a foreign school.
  - (3) They must have completed a 15-year course of study in the educational institutions in a foreign country, or must have completed a 15-year course of study in the educational institutions of a foreign country after taking a correspondence course offered in Japan by a foreign school, by September 2013 and have been recognized by the Graduate School of Engineering as having obtained the prescribed number of credits with superior grades.
  - (4) They must have been recognized to have scholastic attainments that are at least the equivalent of those of graduates of foreign universities, based on an examination, conducted by the Graduate School of Engineering, of the applicant's qualifications to enter this school, and be also 22 years of age or be going to turn 22 by September 2013.

Applicants who would meet the Required Qualifications (3) or (4) above need another procedure in advance. Please see "11 Request for Judging Applicant's Qualification to Take the Entrance Examination".

- (2) Bank transfer charge shall be borne by applicant. #### 5. Selection Method and Date

#### (1) Selection Method

Applicants will be selected based on an examination (an oral interview) and their transcripts of grades. For applicants residing abroad, the examination date and place will be considered and then decided based on the consultation before the admission application. Please contact desired supervisor for more information.

(2) Examination

Oral interview: It will include a check in the basic scholastic ability and a research proposal and so on.

(4) Examination Place

It will be held at the buildings of Faculty of Engineering at Nishi-Chiba campus at Chiba University. Please make sure of the notice posted on the notice board for more details.

- (2) Please be sure to have your Admission Ticket for Examination B2 with you during examination hours.
- (3) Changing the contents of submitted documents following the completion of application procedures will not be allowed. However, if you change your address following application, please provide written notification to that effect (the form to be used is optional).

#### 9. Completion Conditions

The standard residence period in the master's program is two years. It is the necessary conditions to complete the master's program that you must be registered for two years or more, and also take thirty credits or more which are provided by Graduate School of Engineering, and besides, successfully pass inspection of the master's thesis or the result of study on a specific subject, and the final examination.

#### 10. Early Completion

A student may shorten the period required to complete the master's program to one year if the student has

achieved exceptional research results while enrolled in the program.
